

Business Majors Advising Worksheet (2005-06)

Pre-Business is not a degree-granting program. All Pre-business students must complete the Pre-Business freshman core and have a cumulative grade-point ratio of *2.0 or better before* being admitted into a degree-granting program (exception: Marketing requires a 3.0 gpr). Students must complete the freshman core and declare a business major by the end of their sophomore year; however, students should declare their major as soon as they complete the freshman core.

2. Students must complete the general education Cross-Cultural Awareness (CCA) requirement. This may be fulfilled by courses also meeting other curriculum requirements or through a University approved Cross-Cultural experience. See the University listing of approved CCA courses.
3. Financial Management majors are required to have a GPR of at least 2.0 in all FIN designated courses to graduate. Only the last grade for courses that are repeated counts for computing this GPR.
4. Accounting courses may be selected from any 300 or 400 level course offered at the School of Accountancy. Credit may not be received for both ACCT 303 and 307.
